



# BOARD BRIEFING



An Update from the GCPS Public Relations Office

## Public Session 2/11/25

### New Business

- Dr. Jane Wildesen, Director of Human Resources and Chair of the Calendar Committee, presented the committee's proposed 2025-26 GCPS Calendar to the Board for review. The draft calendar is available for public feedback from February 12, 2025, to March 7, 2025. She provided some clarification on the calendar development for the Board. The Board is expected to take action on the calendar at the March 11, 2025, meeting.
- Mr. Paul Edwards, Director of Secondary Education, requested Board approval to set May 28, 2025, as the last day for seniors. Dr. Brenda McCartney recommended approval of this date, and the Board voted unanimously in favor of the measure.

### Continuing Business

- Ms. Gloria Smith, Director of Finance, presented an update regarding state aid revenue for the FY2025-26 budget. She answered various questions from the Board. This was an informational presentation.
- Dr. Jane Wildesen recommended June 9, 10, and 11, 2025, for Board approval as make-up days due to inclement weather closings. Dr. McCartney recommended approval of these make-up days, and the Board voted unanimously in favor of these days. *As previously approved, she also noted February 17th and April 21st as make-up days.*
- Dr. Brenda McCartney, Superintendent, presented her recommendation regarding the northern area proposal, along with Mr. Richard Wesolowski, Director of System Operations, and Dr. Nicole Miller, Chief Academic Officer. They responded to different questions from the Board. The Board is expected to act on this proposal during the March meeting.
