An Update from the GCPS Public Relations Office

New Business

- Dr. Chelsie Manges, Director of Special Education, requested that the Board approve School Therapy Services as the vendor to provide physical and occupational therapy services for the next three school years. Dr. Brenda McCartney recommended approval of the selected vendor. The Board voted unanimously to approve this contract.
- Mrs. Candy Maust, Supervisor of English Language Arts and Social Studies, presented the proposed 8th-grade instructional materials, *US History Voices and Perspectives*, to the Board for review. The materials are available for public review and feedback through April 24, 2024. The Board is expected to take action on the materials at the May Board Meeting.
- Mr. Paul Edwards, Director of Secondary Education, presented the recommended high school environmental instructional materials, *Your World, Your Turn*, to the Board for review. The materials are available for public review and feedback through April 24, 2024. The Board is expected to take action at the May Board Meeting.
- Mrs. Dawna Ashby, Director of Early Childhood and Elementary Education, presented the recommended elementary (K-5) music instructional materials, *Quaver Music*, to the Board for review. The materials are available for public review and feedback through April 24, 2024. The Board is expected to take action on the materials at the May Board Meeting.
- Dr. Nicole Miller, Chief Academic Officer, presented the GCPS Prolonged State of Emergency Plan to the Board for review. She discussed the plan with the Board Members. The Board is expected to take action on this plan at the May Board Meeting.
