Baker, Superintendent; Mr. Brandon Hoover, Attorney Board and asked that they commit to keeping FV open for an additional 10 years.

- Samantha Mager, a junior at Northern High School, has experienced both small and larger schools. She is in favor of the smaller schools and opposes closing FV.
- Erica Mager, a seventh-grade student at Northern Middle School, spoke about her experiences at FV and the activities that are available now. She spoke about the closer bonds students have in smaller schools that wouldn't be found in larger ones.
- Michael Henderson, a community member, spoke in favor of smaller schools. He fears the decision the Board is about to make is going to be a bad one.
- Jill Inser, parent of a Friendsville student, stated that she fears that larger schools will not address student issues and also expressed concerns over the length of bus rides. She fears that younger kids may be exposed to "sex things."
- Bethany Hayhurst is concerned about the lack of a cap on the student-to-teacher ratio. She stated the need to have adequate 1-on-1 time. She fears that the top in each class will succeed while the remainder of the students fall behind. She is also concerned about teachers losing their jobs and stated that we should be looking for incentives to increase enrollment, rather than shut down schools.

The Board approved the contract unanimously.
- Ms. Barbara Baker, Superintendent, presented a minor change to the Organizational Chart for the Board's approval. The Board voted 3-1 to approve the change.
